1. Students Active for the Environment (Safe)

Representatives from SAFE were present to discuss their petition to ban the use of cosmetic pesticides.

They will be petitioning the City to ban pesticides and brought brochures to outline alternatives to these toxins. In March 2004 City Council unanimously voted to prepare a bylaw to restrict the use of cosmetic pesticides, and to date there has been no action. Many other cities have enacted this ban. They include: Vancouver, West Vancouver, Port Moody, Gibsons, Toronto, Montreal, Hudson, QC.

A petition was left with Neil Powell to collect signatures.

2. Sapperton Historical Signage Program

- Mock up of sign was made available for viewing.

- When the approval phase is completed the City sign shop will put out an order to have the signs cut and then they will print out.

3. E. Columbia St Historical Mural

- Graffiti has been removed from wall
- Concept of mural is of a historical map of sites over a timeline. A mock up version was brought for everyone to view.
- This concept includes 6 major images (Stolo First Nations, Sappers Camp, Woodlands, The Pen, Royal Columbian Hospital and the Interurban) as well as other minor mages.
- We must decide whether to paint the mural directly on the wall or put up plywood panelling so that the mural could be removed if the building was ever torn down.
- The New Westminster Community Policing Group has pledged to help cover the cost of Graffiti proofing the mural.

- Next step is to create a more specific sketch and look for any grants and donations.

Truck Traffic on 8th/Braid

- The City is seriously looking into removing truck traffic off of 8th/Braid St.
- They are currently looking for alternatives so that truck traffic can be banned.
- This corridor is not classified as a major road therefore the City does not have to go through the Province to make changes. They however must consult with Translink.
- The City has hired a consultant to look at this as well when a new traffic engineer is hired this will be a top priority for them.
