4. Updates on Sapperton Plaza and Sapperton Skytrain Station Walkway

- Skytrain walkway is now open as of Sept 2, 2008
- Sapperton Plaza: Expectation is to be finished at the end of September

5. Other Business

Air Quality

- Asked Fraser Health Authority for an air quality monitoring station in NW
- Jim Lowrie: Air quality study a temporary Air Monitoring station is to be set up near Sapperton park for monitoring over a 12 month period to test to see if a permanent site needs to be maintained. Monitoring to be completed by Summer 2009 and report expected by October 2009.
- Neil Powell to get permission to send documents out to members.
- Measuring: baseline air quality, ozone CO2, NO2, NO, particulate matter comparison to other monitoring stations around Metro Vancouver.

Labatt's Land questions

- Wesgroup is moving forward with site possibly start with medical building on Keary (high rise)
- Fraser Health has not committed to what they need in the area this is what is holding this up.
- Wesgroup has 5 phases for the area. All need permits.
- Looking to do most of the prep work up front.

- New development 15 unit property on Ward St. coming to council with proposal to City. Need to present to RA if it is to go any further.
