1. Welcome and Introduction of Executive

Wilf

- Positions of Chair and Co-Chair: still vacant.
- If anyone is interested, they can put their name forward to join the Executive.
- Reminder to pay \$5 annual dues to Anita, either in person or by sending an etransfer to the RA email.

2. Adoption of Agenda

Wilf

- Motion to Approve; Seconded. Vote: Carried.
- Addition of three items: 1) Trash mob update 2) St. Michael's Christmas market 3) e-scooters.

4. RCH Redevelopment Project -

Anita

- Anita reached out to RCH, but no one was available to attend today's meeting

- Questions: When the parking lot opens under the new building, will it be open to the public? What is the estimated date for the opening of the entrance to the ER?

5. E.Fry Christmas Gift Bags

Eileen

- We will be doing 17 gift bags again this year.
- Eileen has gone around the local businesses and received cash from Asher Acupuncture.
- The cut off for donations will be November 30.
- Eileen is hoping to use cash donations to buy items during Black Friday sales.
- So far, \$145.00 cash has been donated.
- Eileen has purchased items from Bath and Body Works
- Any extra items will be donated to the E.Fry drop-in program.

6. Light Up Sapperton

Anita

- Date: Sunday, Dec. 7 from 12 to 6 pm
- Free event. Register at Sapperton Plaza and kids will be given a passport to go around local business to get items.
- There will be a mini market at Cap's plaza and a larger craft market at the Brewery District
- Santa Claus and other holiday characters will make an appearance.
- There will be a photo booth.
- The organizers are looking for volunteers.
- The RA is going to collect food for St. Alban's Presbyterian Church food bank. This will come back to Sapperton for distribution here. We are also collecting new toys and items for teens.
- The RA will share a booth with the Light Up Sapperton organizers and members of the Executive will take turns at the booth during the event.

7. Patullo Bridge Replacement Project

- Reminder that there will be upcoming road closures as the ramps to the bridge are finalized.

9. Police Committee Update

- Eileen reported on this at the last meeting. No news since then.

10. Trash Mob Update

Anita

- Anita sent in an application for a City of New Westminster grant for the 2026 event. She is waiting to hear back.

11. St. Michael's Christmas Market

- Taking place at St. Michael's School on Holmes Street. Admission is free and there will be 36 vendors.
- Date: Nov. 22 from 11 am – 4 pm.

12. E-Scooters in New Westminster

Wilf

- Wilf attended a panel discussion at Century House regarding eScooters and other "micro mobility" vehicles. There were representatives there from NWPD and the Engineering Department, and the Mayor and a couple of councillors were in attendance.
- The injury rate for riders of scooters and micro-mobility vehicles is steadily increasing. Injuries include facial and jaw injuries.
- In New Westminster, apart from bikes and ebikes, micro-mobility vehicles are illegal.
- However, the City's attitude is it wants non-motor vehicle traffic to "get along" with each other.
- The police's response is they will not do anything unless someone is killed or injured.
- The issue of micro mobility vehicles does not appear high on anyone's agenda..

 - Any other residents who are interested in joining the Executive are encouraged to do so.

Councillor Nakagawa joined the meeting late (at 8:15 pm) on behalf of Counc. McEvoy. Some information that she conveyed:

- a) The library is undergoing a Facilities Masterplan Process. Some questions for residents to consider: Are people in our community interested in a “library outpost” in Sapperton? They would love feedback. She will send the link to the RA so it can be shared with residents for input.
- b) The City has hired a new COO who will be replacing Lisa Spitale. This will inevitably mean there will be new ideas for the City in coming months.
- c) The budgeting process is rolling out. Stay informed.
